This investigation resulted in the ACLU winning a multi-million dollar class action lawsuit on behalf of individuals and organizations.
- From March 1986 to present, working for attorneys Chokwe Lumumba, Jonathan Lubell, Michael Warren and Teri Thompson, doing investigations and research on the political and legal defense of Dr. Mutulu Shakur, currently serving a sixty-year Federal Prison sentence under the RICO statute.
